## Board Of Director (NEOA)

- I am over eighteen years of age, a citizen of the United States and a resident of the State of Connecticut. If called upon to do so, I could testify of my personal knowledge to the facts contained within this declaration.
- I am presently a detective with the Special Investigations Division of the Danbury
  Police Department and a member of the department's SWAT (Special Weapons and
  Tactics) Team, in the State of Connecticut.
- I have been a Police Officer for the past seventeen years.
- 4. I have know Frank Dux for several years, during which time I have been trained by Frank Dux and observed Frank Dux provide training to numerous Law Enforcement Officers. This training includes SWAT CQB (Close Quarter Combat), undercover operations, undercover conduct and planning and officer safety.

- 5. In 1995, Mr. Dux's experience and skills were put to the test by the Danbury Police Department's SWAT Team, both as a participant in various training scenarios and by solving highly technical and hazardous tactical problems indigenous to our area.
  Frank Dux solved complex tactical problems that our SWAT Team training had not been able to solve in the past. Our SWAT Team has attended training from Elite Military units as well as the FBI during their advanced SWAT School.
- I am a member of the Board of Directors of the Narcotics Enforcement Officers
   Association ( NEOA ) a national advanced police training organization.
- 7. I am an experienced narcotics officer who has participated in all aspects of narcotics investigations to include undercover, raids, surveillance and teaching narcotics classes while assigned to the Special Investigations Division and Tactical Narcotics Team.
- 8. In 1996, because of Frank Dux's unique experience and expertise in conducting covert operations, Frank Dux, through efforts of the Multi-Jurisdictional Task Force located in St. Peterburg and the federal funding of Mr. Dux's expenses, Mr. Dux was invited to be the key note speaker-instructor at our annual Criminal Investigations School, then held in Springfield Massachusetts.

- Mr. Dux lectured and instructed a class on officer safety, undercover operations and planning to approximately 200 highly experienced officers and detectives.
- 10. Each speaker, as a matter of NEOA policy, was reviewed and criticized in a questionnaire provided to each of the attending officers. Mr. Dux's lecture based upon receipt of these written reviews, received the most outstanding rating possible from, remarkably, by each of the attending officers and detectives.
- 11. Mr. Dux's ability and knowledge of undercover covert operations and SWAT displays the highest caliber of professionalism. To the best of my knowledge this, the kind that can only come with empirical experience.
- 12. Frank Dux has been a friend and ally to the Law Enforcement Community.
